WHEREAS the trust shall be an irrevocable public educational, cultural trust for the benefit of all persons belonging to all strata of society, irrespective of Community Caste, Creed or Religion.

NOW THIS INDENTURE WITNESSTH AS FOLLOWS:

NAME

The name of the Trust shall be "TRISHAKTI MANAGEMENT TRUST". The Trust will function as a non-communal and a secular organization.

PLACE

The principal office of the Trust shall be situated at PURUSHOTTAM NAGAR 4TH LANE BERNAMPUR, DIST. GANJAM or such other place as the Trustees may from time to time decide. The Trust may also carry on its work at any other place or places, as decided by the Trustees.

3. AIM & OBJECTS

The objects for which the Trust is founded are:

- a) To establish, run, maintain or assist Institutions for pre-school education, school education, higher education, technical education, management education, professional education and other general education for imparting quality education to achieve continuous improvement of human capital in the country

- To grant financial aid, scholarships, textbooks, notebooks, uniforms/ cloth, meals to the poor, deserving and needy students enrolled for elementary, secondary, higher education or professional education.
- To establish run, maintain or assist medical or Para- medical educational institutes, hospitals, nursing homes or clinics and to provide financial assistance to needy and indigent persons of the society for meeting the cost of medical treatment.
- To grant financial or other assistance in kind for the poor & indigent and to the persons who suffer due to natural calamities.
- To establish run, maintain, libraries, reading rooms, crèche, Family Welfare Centers, and Community Halls for public use for conducting training classes, seminars, discourses, workshops and other public functions for benefit of the community in general.
- To establish run, maintain cultural, social training institutions/ centers and teachers' training institutions and research & training centers for the furtherance of cause of education/learning in the society
- To acquire and maintain the movable and immovable properties by outright purchase or on lease or on Build -Operate- Lease & Transfer (BOLT) basis for achieving the said objects.
- To advance any other objects of general public utility and charities.
- To undertake any other activities incidental to the above activities but which are not inconsistent with the above objects.

CHAIRMAN:

There shall be a chairman for the administration of this trust, nominated by the board of Trustees, who shall be one amongst trustees.

MANAGING TRUSTEE:

The day-to-day administration of the Trust shall be looked after by the Managing Trustee, under the guidance, control and supervision of the Board of Trustees

- (ii) The Board of Trustees shall nominate one amongst the trustees, who shall hold office for such period, as may be decided by the Board of Trustees.
- (iii) The Managing Trustee shall perform all functions, discharge such duties as or specifically entrusted to him/her in writing by the Board of Trustees.

6. NUMBER OF TRUSTEES/ VACANCIES:

Apart from Author trust will have a minimum of 2 (TWO) trustees. If at any time the number of the trustees is less than two, the existing trustee shall appoint one or more trustees. Upon the appointment of a new trustee the trust properties shall vest in the new trustee jointly with the continuing or surviving trustees, with the duties and power of the trustees set out hereinabove in this deed

MEETING AND PROCEEDINGS OF THE TRUSTEES:

The Trustees shall ordinarily meet once in 3 (THREE) months or as often as may be necessary for the satisfactory conduct of the affairs of the Trust. In case of any difference between the trustees, the opinion of the minority shall prevail.

8. TERMINATION / APPOINTMENT OF THE TRUSTEES:

- (a) Trustee shall cease to hold office:
 - i) If he dies,
 - ii) If he resigns,
 - iii) If he is adjudged insolvent or found guilty of an offence involving moral turpitude

- (v) If he is found to have acted against the interest of the Trust. If it is unanimously decided by the Trustees that his continuation in the Office is against the interest of the Trust.
- (b) Any of the trustees may retire on giving one month's notice in writing to the other trustee(s).
- (c) If any trustee dies or retires or becomes incapable or unfit to act, the continuing or surviving trustee or trustees shall appoint a successor in the place of such trustee

POWER OF TRUSTEES

That the trustees shall have the following powers

- a To manage all the assets and/or properties of the trust including the conduct of business
- b To appoint employees and to settle the terms of their service, remuneration and termination
- c To look into the management of the trust.
- d To invest the funds of the trust in bank or in the purchase of company shares or securities or other movable and immovable properties
- e To sell, alter, vary, transpose or otherwise dispose or alienate the trust properties or any investment representing the same for consideration and to reinvest the same
- f To pledge or mortgage the trust properties for raising loans
- g To open the bank accounts in the name and on behalf of the trust and to operate the same
- h To enter into a partnership on behalf of the trust with any other party or parties

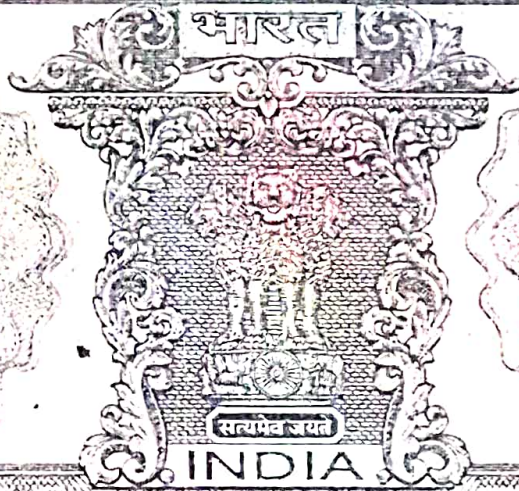

- l. To pay all charges, impositions and other outgoings payable in respect of the trust properties and also to pay all cost of the incidental to the administration and management of the trust properties;
- j. To file suit on behalf of the trust and to refer to arbitration all actions proceedings and disputes touching the trust properties and to compromise and compound the suits filed;
- k. To accept any gift, donation or contribution in cash or in kind from anyone for the objects of the trust;
- l. To seek legal opinion of lawyers and/or Chartered Accountants as and when required. To nominate their representatives for any of the aforesaid purposes.
- m. Every trustee will be at liberty to nominate or appoint attorneys or agents and to delegate all or any of the duties and powers vested in him to such attorney or agent and to remove such attorney or agent and reappoint other or others in his place
- n. No trustee shall be responsible or liable for any loss or any act of omission or commission by his constituted attorney or agent or employees or other trustees unless occasioned by his willful neglect or default.

10. FUNDS.

The Trustees may accept donations, grants, subscriptions, aids or contributions from any person, Government, Local authorities or any other charitable institutions, in cash or in kind including immovable property without any encumbrance, but the Trustees shall not accept any receipt with any condition or terms inconsistent with the objects of the Trusts. While applying such receipts to the objects, the Trustees shall respect the directions, if any, by the granter

11. INVESTMENTS:

All monies which shall not immediately required for current needs shall be invested by the Trustees in eligible securities and investments as notified by government of India or in scheduled banks. Such investments shall be in the name of Trust

12. BOOK ACCOUNT:

- (i) The Board of Trustees may open such Bank Account or Accounts in any of the Banks in the name of TRISHAKTI MANAGEMENT TRUST. The Chairman and Managing Trustee or any other Trustee shall jointly operate such accounts.
- (ii) The trust may also open Bank Account/s in the name of Institution / organization founded by the Trust. These Bank Accounts shall be operated by such persons, as authorized by the board of trustees from time to time.

APPLICATION OF THE PROPERTIES OF THE TRUST:

- The properties and funds of the Trust shall be applied only for the purpose of the Trust and for the due administration of its business affairs and properties provided however that this shall not preclude payment of any temporary remuneration or allowance or giving of residential accommodation or any perquisites to any trustee in connection with the work carried out by him for the purpose of the Trust.

DEFECTS OF PROCEDURE IMMATERIAL:

No act of trustees shall be invalidated by reason only of any vacancy in the Board of Trustees or any irregularity in the proceedings of the Board of Trustees or any Committee thereof

15. AMENDMENTS:

No amendments to the Trust Deed shall be made which may prove to be repugnant to the provisions of Section 2(15), 11, 12 and 13 and §OG of the Income Tax Act, 1961 as amended from time to time.

16. BANKING ACCOUNT :

All income, subscription and pecuniary dopations for the general purposes of the Trust and the income, investments and all other moneys from time to time forming part of the general revenue of the Trust shall on the same being received be paid into a banking account with any scheduled bank for the purpose of the Trust. These bank accounts shall be operated by the Managing Trustee along with any one of the remaining Trustees.

ACCOUNTS AND AUDIT :

The Trustees shall keep proper books of account of all the assets, liabilities and maintain a true and correct record of the receipts, payments incomes and expenses and transactions of the Trust and shall prepare an Income and Expenditure Account and Balance Sheet for every year as on the last day of March. The accounts shall be audited by a Chartered Accountant or a firm of Chartered Accountants, who shall be appointed for that purpose by the Trustees. The audited accounts shall be placed at a meeting of the Trustees, which shall be held before the end of the succeeding year.
